

SPECIAL TOWN MEETING WARRANT FY2012

To either Constable of the Town of Rowe in the County of Franklin,

GREETING:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the inhabitants of the Town of Rowe, qualified to vote in the elections and town affairs, to meet at the **ROWE ELEMENTARY SCHOOL** in said **ROWE** on **WEDNESDAY**, the **TWENTY-FIRST** day of **DECEMBER 2011**, at **7:00 P.M.** in the evening, then and there to act on the following:

ARTICLE 1: To see if the Town will vote to **APPROPRIATE** from the **STABILIZATION FUND** the sum of **\$63,000.00** for **Grade 7-12 Public School Tuition**, or take any action in relation thereto.

ARTICLE 2: To see if the Town will vote to **APPROPRIATE** from the **STABILIZATION FUND** the sum of **\$30,000.00** for a **Forensic Financial Audit**, or take any action in relation thereto.

ARTICLE 3: To see if the Town will vote to **APPROPRIATE** from the **STABILIZATION FUND** the sum of **\$6,000.00** for **Legal Expenses**, or take any action in relation thereto.

ARTICLE 4: To see if the Town will vote to **APPROPRIATE** from the **STABILIZATION FUND** the sum of **\$50,000.00** for **Legal and Consulting Expenses** regarding the **Town of Rowe's** tuition arrangement for **Grade 7-12** students with the **Mohawk Trail Regional School District**, and related matters, or take any action in relation thereto.

ARTICLE 5: To see if the Town will vote to pay two **PRIOR YEAR BILLS** in the total amount of **\$100.00** from the **Police Department Operations** account, one **PRIOR YEAR BILL** in the amount of **\$150.00** from **General Administration** account, and one **PRIOR YEAR BILL** in the amount of **\$1,120.00** from **Board of Health Operations**, or take any action in relation thereto.

NOTE: 9/10ths vote is required to pass Article 5

ARTICLE 6: To transact any other business that may lawfully come before the meeting.




