#### **Transfer Station:**

- The Transfer Station logs were reviewed and read by Herb Butzke.
- Christine will email the Fire Department for their recommendations on a follow up from FCSWMD, Jan Ameen suggesting the Refuse Garden's propane tanks be housed in a storage area.
- Christine ordered 3 more clickers for the Refuse Garden's gate. Two will go to the Highway Department for when plowing is needed. The other one is a replacement for the office which was given to the Salvation Army. Herb will program the new clickers.

### **FY25 Budget:**

- 1) A motion was made and approved to submit a Capital Improvement of \$150,000.00 to the Finance Committee for the repayement of the Transfer Station. This was the estimate amount Herb received from Lance Larned, Highway Department.
- 2) Jan Ameen, FCSWMD submitted the FY25 budget. The additional adjustment is primarily due to the upswing of hauling prices.
- 3) The next budget meeting for BOH to meet with the Finance committee is Thursday, February 1, 2024.

## **BOH Updates**:

- 1) Kathy Atwood submitted the annual report for the Board review/approval. A motion was made and approved to submit the Board of Health Annual Report to the Town Administrator.
- 2) The BOH received an email from the FRCOG Training Hub. The Training Hub offers a Foundations Course which is now available on <u>TRAIN</u>. The Foundations course is required per the <u>Workforce Standards</u> for Directors/Agents, Inspectors, Public Health Nurses, and BOH members (within 1 year of appointment).
