



## Application for Use of Park Facilities

**Pelham Lake Park is owned by the townspeople of Rowe** and is maintained by the Town for their reasonable use and enjoyment of the facilities.. The Park Commission has extended this privilege to designated guests of Rowe townspeople, to Rowe seasonal residents, and other local taxpayers. For group reservations for 15 or more, an **eligible person** must apply and be personally present and responsible during the entire event. The Park Ranger may approve groups up to 50 persons. Applications for "over 50 persons" should be addressed to Park Commission, at least two months prior to event.

**Reminders / Some Pertinent Park Rules** (Ask Ranger for complete list of regulations)

1. The Park Ranger and Staff may offer assistance, but are not servants for those using the facilities.
2. The normal staff hours are from 8:00 AM to 4:00 PM. The Park Gate closes at 9:00 PM
3. Beach parking lot is reserved for townspeople. Guest's cars must be parked outside park entrance.
4. It is your responsibility to hire Private Lifeguard(s) if using the Beach area after 4:00 PM and after August.
5. It is your responsibility to pick up and remove your picnic trash from the area and to extinguish all fires.
6. No pets permitted in beach area and no loud music or other disturbance of neighbors is permitted.
7. Park regulations prohibit Alcoholic Beverages.
8. Due to the inherent hazards and risks of outdoor recreation activities, the applicant and guests shall assume all risk of injury to their persons or property that might occur from their use of any Park Department facilities.
